SB 1720 SECTION 118.1 REQUEST FOR INFORMATION RE: “A NONPROFIT ORGANIZATION THAT IS DESIGNATED AS AN INTERNATIONAL DARK SKY DISCOVERY CENTER AND THAT IS FOCUSED ON DARK SKY PRESERVATION IN THE STATE”

1. INTRODUCTION

To comply with SB 1720 Section 118.1, the Arizona State Treasurer’s Office (ASTO) is issuing a request for information (“RFI”) to assist it develop a grant program to distribute the appropriated monies pursuant to A.R.S. § 41-2701 *et seq.*¹

Under SB 1720 Section 118.1, the Arizona Legislature “appropriated from the state general fund in fiscal year 2023–2024 to the state treasurer ... \$10,000,000 to distribute to a nonprofit organization that is designated as an international dark sky discovery center and that is focused on dark sky preservation in this state.”

Any request must serve a purpose that may include education, conservation, economic development, etc. ASTO issues this RFI to obtain information regarding how to best structure the grant program (i.e., determine which nonprofit entities qualify and what are the nonprofits’ intended purpose and use for the monies).

At the conclusion of the grant process, ASTO intends to enter into a grant agreement with the qualifying nonprofit(s) to ensure the funds comply with an acceptable public use.

Note that pursuant to A.A.C. R2-7-G301, responses to a RFI “are not offers and cannot be accepted to form a binding contract.” Note also that “[i]nformation contained in a response to a request for information shall be considered confidential until the procurement process is concluded or two years, whichever occurs first unless authorized by the state procurement administrator.”²

2. INFORMATION TO PROVIDE

2.1 SB 1720 Section 118.1 appropriates “from the state general fund in fiscal year 2023–2024 to the state treasurer ... \$10,000,000 to distribute to a nonprofit organization that is designated as an international dark sky discovery center and that is focused on dark sky preservation in this state.” Therefore, please include in your response answers to the following:

1. Whether the organization is a nonprofit organization qualified under section 501(c)(3) of the United States Internal Revenue Code for Federal Income Tax Purposes.
2. Whether the organization is designated as an international dark sky discovery center (and if so, by which accrediting body).

3. Whether the organization is focused on dark sky preservation in the State of Arizona (and if so, please explain how it furthers that preservation focus).
4. What is the organization's intended public purpose for the SB 1720 Section 118.1 funds that are set to be distributed?
5. A detailed explanation of how the organization intends to use the funds and how the value received to the public from the organization's proposed use far exceeds what is being paid by the public through the appropriation.
